Request for information

"Can you please furnish me with statistics and any other data held regarding complaints raised with ICO about Nominet UK (company 03203859) such as but not limited to; the number of complaints as yet unhandled, number of complaints by month, statuses and outcomes of those complaints. Where possible these would ideally be provided in digital format to minimise cost and environmental impact.

Please extend the request backwards on a monthly basis for so long as records exists or otherwise as far back as the Regulation 3 reasonable limit for fees."

Your request has been handled under the Freedom of Information Act 2000 (the FOIA). As you are aware, this legislation provides public access to recorded information held by a public authority unless an appropriate exemption applies.

Our response

We can confirm that we do hold information in scope of your request. Please find attached a dataset of our casework regarding Nominet UK.

Our searches focussed on all complaints held, up to the date of your request, where Nominet UK is the 'Submitted About' account. Our searches covered our existing and previous casework management systems. The only data found is from our current system, ICE360.

Please note that in line with our retention policy and the relevant legislation, we do not retain information about cases indefinitely. Therefore, records for cases concluded more than two years ago will not be complete.

This concludes our response to your request.

FOI review procedure
